

#### ALCTU APPROVES FUNDING FOR LITTLE WILLOW CREEK

At the Board meeting on April 12, the Board approved a \$500 contribution toward a new habitat restoration project on Little Willow Creek in Richland County. A new parcel, located upstream from but not directly connected to the parcel where improvements were just completed last year, will be the focus of a new habitat project this year. An easement is also being obtained.

This new stream segment supports spawning activity by the wild brookies of the Little Willow, and is an outstanding opportunity for us to lend our support to the strengthening of native trout populations in the Driftless Area. Partnering with us on this project will be the Blackhawk, Coulee and SE Wisconsin Chapters.

#### ORVIS CONSERVATION GRANT AWARDED TO ALCTU

An Orvis Conservation Grant of \$2000.00 has been awarded to the Aldo Leopold Chapter to be applied to construction of a board walk and educational viewing platform on the banks of Manley Creek in the Riverland Conservancy in Sauk County. Construction will be completed in late Fall 2017.
